



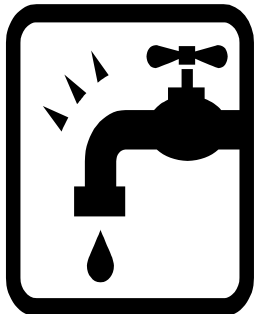

- A 4 hour state certified course for individuals required to re-certify the NPDES Level 1A (Blue Card) which expires every three years. **There will not be an exam for this recertification course.**
- Individuals that attend approved course(s) must present the instructor with government issued photo ID and current certification card or proof of valid certification (from GSWCC website).
- Individuals can begin taking continuing education courses 1 year before their certification expires.
- Individuals will receive a new certification card in the mail approximately two weeks before their certification expires.
